A roadmap to GDPR Compliance for your non-profit organisation



What is GDPR?

The General Data Protection Regulation (GDPR) intends to protect the data of European Union citizen and covers all personal data relating to an identifiable natural person, such as names, addresses, bank records, insurance, online behaviour, etc. As of May 25th, 2018, compliance is mandatory for all organisations handling such data.

Ensure your organisation's GDPR compliance to:

Protect the personal data of your staff & external parties Improve the quality of internal information management Increase secure data management practices Promote an image of reliability Avoid hefty fines
